#### FINANCIAL REPORT:

Treasurer Givens presented SRA Treasury Status – currently we have a Balance \$17,000, with bills due.

Membership update: there are 143 residents that have paid the annual membership dues, again with some residents paying extra amount. Our target was 190 homes – still a ways to go. Good time to send out a reminder. Also, we thank the generosity of several of our members, in paying extra for our yearly dues. Givens will send a list of those in the neighborhood – to see who has paid and who has not yet paid to each Board Member.

In addition, Givens will also be responsible for placing PayPal on the website – this would be for payment of dues.

Song also reminded that we would be reimbursed \$2,000 from City regarding the Security Cameras.
